### **RECOMMENDATION:**

BE IT RESOLVED THAT THE COUNCIL OF THE TOWN OF GANANOQUE APPROVE A BUDGET DEVIATION TO AN UPSET LIMIT OF \$142,000.00 FOR THE LAGOON ROAD AND BERM MAINTENANCE PROJECT, AS PRESENTED IN COUNCIL REPORT UTIL-2023-14.

# **BACKGROUND:**


Council approved to fund this project earlier in 2023 through By-law No. 2023-082. As the project has progressed, a few unforeseen instances have come up that cannot be absorbed within the contingencies of the approved budget. The project was awarded to Robert Nash Excavating, and EVB Engineering has been performing our on-site inspections and administration with our Superintendent of Water & Wastewater.

### INFORMATION/DISCUSSION:

Town staff have worked closely with the consultant and contractor throughout this project. Due to the amount of large rocks being removed during the excavation process, an additional 1500m³ of clay is necessary to fill these voids with acceptable material. An itemized breakdown of the additional costs is outlined below:

Item	Additional Funding
	Required
Nash – Additional 1500m³ Clay Placement and Grading	\$92,000
Nash – Additional 50m Geosynthetic Clay Liner	\$23,000
Dundee Marine – Bypass work for re-filling Cell 1	\$12,000
Quinte Sewer – Clear effluent pipe prior to re-filling Cell 1	\$5,000
EVB Engineering – Additional Administration	\$10,000
Total	\$142,000

The installation of an additional 50 metres of geosynthetic clay liner is required to extend the keyway connection for the berm repairs of Cell 1, outlined below in red.

# FINANCIAL CONSIDERATIONS/GRANT OPPORTUNITIES:

The budget deviation can be funded through the anticipated funding surplus of the Biosolids Removal project at the Lagoon. This project is nearly completed and there is an anticipated surplus of approximately \$300,000 from the approved budget amount.
