Impact of Tax Levy Increase on Fixed Income Seniors

Cost of Single-Family Dwellings

- 1. The average sale price of a single-family detached dwelling in Gananoque has roughly tripled between 1999, and 2018. In 1999 the average sale price of a home in Gananoque was approx. \$103 202.00. The average price of a single-family home in Gananoque in 2014 was \$ 169 469.00 across 90 sales and in 2018 it was \$ 242 052.55 across 98 sales. Note: this data extracted from the REALTOR.CA database, and does not include managed sales of condominiums which would have skewed the average higher.
- 2. During the same period (1999 to 2018 inclusive) inflation averaged 1.917% per year in Canada. Compounded yearly at that inflation rate the average price of a home sold for \$103 202 in 1999 in Gananoque should have risen to \$\$150,876.20 in 2018.
- 3. The average cost of a single-family home in Gananoque in 2018 is 234% of the cost of the same home in 1999, for an average annual rate of increase of 11.7% per year, massively outpacing the CPI inflation rate.

Land Rich vs Cash Poor

- 4. The income of fixed income seniors has increased, if it has increased at all over the period 1999-2018 at a rate tied to inflation, namely an average increase of 1.917% per year.
- 5. The net effect is that the value of their property has increased at a rate wildly disproportionate

Impact of Tax Levy

- 6. Based on an increase in value of 11.7% per year, the average property owner in Gananoque is paying roughly \$1000 more in property taxes per year than they would have if property had appreciated in line with inflation.
- 7. Coupled with the \$600 water levy which was added only recently and which is in reality a tax to make up for historically low property tax rates, this increased burden of \$1600 per year again falls harder on fixed income property owners.
- 8. This is \$133.33 per month. That buys a lot of groceries, or it would if it were still in their pockets.

Acknowledgement by Council of Disproportionate Impact of Levy Increases on Fixed Income Seniors

- 9. I formally request that this council acknowledge that the effect of any increase in tax levy is felt disproportionately by fixed income seniors.
- 10. I formally request that this council seek means to mitigate this impact.

Deputation to Gananoque Town Council - 17 Sept 2019

Management of Water Lot Rentals and Use Control

Background

- 1. The Town of Gananoque Official Plan and the Gananoque Development Permit By-law are largely mute on the subject of management of water lots controlled by or adjoining the Town of Gananoque.
- 2. Historically, mis-management of water lot use has changed the aspect of not only the waterfront on the St Lawrence, but also the lower Gananoque River. I cite the example of Council on July 17 2018 agreeing to forgive more than \$36 000 of rents from the new owners of Brennan's Marine in order to have them remove docks which Council had approved, and which reached most of the way across the Gananoque River. A similar example is the permanent construction of a roofed dock which has completely changed the aspect of the Gananoque waterfront, and shaped the approach to the docks used by the 1000 Island Boat Line. The degree of change in the waterfront is dramatic, and not an esthetic improvement in my opinion which is shared by many.

Current Situation

- 3. The lack of a coherent policy makes management of the water lots difficult, and lack of prohibited uses raises the spectre of a private property owner making a use which would not be in line with the current lower town development plan.
- This loophole needs to be closed.

Recommendation

- 5. This Council pass an amendment to the Gananoque Development Permit By-Law which makes commercial marinas a prohibited use on the banks of the St-Lawrence East of Stone Street, and West of the Town Marina. One Took, Two Bearts Property
- This amendment must be incorporated into the new Town Plan when approved.
